### COMPLIANCE WITH NOTIFICATION OBLIGATIONS

Note by the Secretariat<sup>1</sup>

Revision

1. The present document reflects Members' compliance with their regular notification obligations as at 28 September 2011.<sup>2</sup> It has been updated to take account of the notifications received since the 23 June 2011 meeting of the Committee on Agriculture.

2. The time limits for all notifications concerning the 1995-2009 implementation years have now passed, hence outstanding notifications can be precisely identified for that period. The column concerning the 2010 implementation year is provided for information only and does not necessarily indicate that the notifications are now due.

3. The document is presented in four sections:

- Explanatory Notes;
- Section A: Outstanding notifications for the 1995-2005 implementation years;
- Section B: Notifications issued for the 2006-2010 implementation years;
- Section C: Table ES:3 and Table NF:1 notifications issued for the 2005-2009 implementation years.

## I. EXPLANATORY NOTES

### A. NOTIFICATION OBLIGATIONS

4. Notifications are to be submitted according to the relevant annual implementation bases as specified in Schedules. In each case the annual notifications are required to be submitted no later than a certain number of days following the end of the "year" in question. These deadlines are indicated below in brackets (for more detail see relevant sections of G/AG/2).

5. "*Comprehensive one-off*" *Table MA:1 notifications* (Implementation of tariff and other quota commitments; Article 18.2 – 30 days) were required to have been submitted by all Members with tariff and other quota commitments, either in advance of, or within 30 days of, the first opening of the tariff quotas concerned; any subsequent changes to the administration of tariff and other quotas are to be notified within 30 days. Where the comprehensive Table MA:1 notifications have been revised or supplemented, this is indicated by an asterisk in the relevant column.

6. *Table MA:2 notifications* (Imports under tariff and other quotas; Article 18.2 – 60 days) are required to be submitted annually by Members with tariff and other quota commitments specified in Section I-B (or Section I-A) of Part I of their Schedules for the products concerned.

7. *Table MA:5 notifications* (Special safeguard; Articles 5.7 and 18.2 – 30 days) are required to be submitted annually by Members which have reserved the right to have recourse to the Special Safeguard provisions as indicated in Section I-A of Part I of their Schedules.

8. *Table DS:1 notifications* (Domestic support; Article 18.2 – 90 days or 120 days if the initial notification is provisional) are required to be submitted annually by Members with base and annual commitment levels specified in Section I of Part IV of their Schedules. All other Members should submit an annual Table DS:1 notification, provided that in the case of a developing country Member only Supporting Tables DS:1 to DS:3 may be required to be submitted annually (see G/AG/2, page 11). Least-developed country Members should submit Supporting Tables DS:1 to DS:3 every other year only (indicated by the symbol (NA)).

9. *Table ES:1 notifications* (Export subsidies; Article 18.2 – 60 days or 120 days if the initial notification is provisional) are required to be submitted annually by Members with base and annual commitment levels specified in Section II of Part IV of their Schedules. Members with no such scheduled commitments are required to submit a notification annually (within 30 days) in the form of a statement confirming that no export subsidies exist or, in the case of developing country Members using certain export subsidies pursuant to Article 9.4, in the form of Supporting Table ES:2.

10. *Table ES:2 notifications* (Total exports; Articles 10 and 18.2 – 120 days) are required to be submitted annually by Members with export subsidy commitments specified in Section II of Part IV of their Schedules and by "significant exporters" as listed in G/AG/2/Add.1.

11. *Table ES:3 notifications* (Food aid volumes; Article 10 and 18.2 – 120 days) are required to be submitted annually by all donor Members for all donated products (except for those products in respect of which this information must be notified under Table ES:1 above). No "nil return" is required.

12. *Table NF:1 notifications* (Food and other aid in the context of the Marrakesh Decision; Article 16.2 – 60 days) are required by all donor Members in respect of actions taken within the framework of the Decision on Measures Concerning the Possible Negative Effects of the Reform Programme on Least-Developed and Net Food-Importing Developing Countries. No "nil return" is required.

## B. EXPLANATION OF SYMBOLS

13. A blank indicates that the requirement applies to the Member concerned for the implementation year, but that no notification was received up to the cut-off date.

14. "X" indicates that a notification has been issued. No assessment of the content or quality of the notification with respect to requirements is made or implied.

15. "P" for pending/in processing indicates that a notification has been received, but that either a request or suggestion by the Secretariat for additional information in order to complete the notification has yet to be responded to, or that the notification is in processing for circulation. A pending notification will be marked as "P" for a maximum period of six months.

16. "X\*" indicates that the comprehensive Table MA:1 notification has been revised or supplemented.

17. "<sup>a</sup>" indicates that information concerning food aid (column 5 of Table ES:1) has not been provided.

18. "NA" indicates that the requirement was not applicable during the period covered either because there are no relevant commitments (e.g. tariff quotas) or because the Member concerned was not yet a WTO Member hence there were no notification requirements pertaining to that period. "(NA)" indicates that domestic support notifications are required every second year from LDC Members.

19. Shading indicates that the Member concerned has a domestic support and/or an export subsidy reduction commitment shown in Section I and/or Section II of Part IV of its Schedule.
