Description of content: This Order of the Minister of Agriculture, Food and Consumer Protection provides some protective measures against the outbreak of foot and mouth disease in District San Pedro (Paraguay). Stopping the import of all live animals (domestic and wild) like cattle, pigs, sheep and goats; stopping the import of meat and products of the above-mentioned animals and milk from the territory of District San Pedro (Paraguay) to the Albanian territory. The veterinary certificate should guarantee their origin. The measures also consist in stopping the import of animal feeding products that content products from animal origin; stopping the import of not sterile biological materials from the territory of District San Pedro (Paraguay) to the Albanian territory.
