#### UPDATE ON PRODUCTS TESTED FOR PHTHALATE CONTAMINATION

14 July 2011: AVA has been testing beverages, jams and jellies manufactured in Taiwan, for phthalates, in view of the phthalate contamination situation in Taiwan. All consignments of beverages, jams and jellies imported from Taiwan are subjected to "hold and test". This means that only products that have cleared AVA's tests for phthalates will be released for sale. Products that fail our tests will be suspended from import.
