For importation of traditional chinese drugs (the content of formula in drug (import) license written by chinese) : (1-a) A photocopy of drug (import) license (non-licensed importers shall submit an application together with an authorization documentation issued by the holder or a stamp on the photocopy of drug license indicating that authorization to use relevant license has been granted) issued by the Department of Health, Executive Yuan or an approval issued by the Committee on Chinese Medicine and Pharmacy, Department of Health, Executive Yuan is required. And(1-b) A photocopy of the license of pharmaceutical firms (such a requirement is exempted for those imports with an approval for import of drugs from the Committee on Chinese Medicine and Pharmacy, Department of Health, Executive Yuan) is required. (2) If the imported goods are samples or gifts, an approval letter issued by the Department of Health, Executive Yuan or the Committee on Chinese Medicine and Pharmacy, Department of Health, Executive Yuan is required.
